Amendments to core opening hours regulations.	Key Change: A new application route (Regulation 26(2ZB)) introduced, allowing pharmacy owners greater flexibility to apply to change core opening hours, provided the change better meets patient and user needs • Find out more here .	
In place from 23 rd June 2025	This change offers pharmacy owners more control over operational hours, aligning services more closely with community requirements.

NHS Mail	Ensure you access your personal NHS.net email regularly (at least once every 30 days) to avoid your account being deleted. Further information is available here.	
Pharmacy Profile Update	Ensure your Directory of Services and NHS website profiles are up to date by updating your NHS Profile Manager . This quarter starts on 1st July 2025 and ends on 30th Sept 2025. We encourage you to do this ahead of the August Bank Holiday	
PharmOutcomes Access	Check that pharmacy staff have access to PharmOutcomes during all opening times, especially when locums are on duty; set-up additional accounts if needed. PharmOutcomes must be checked regularly throughout the day and referrals and messages received actioned.	
Community Pharmacy Devon Mailing List	Encourage locums and the rest of your pharmacy team to join our mailing list to ensure they are up to date with changes. Visit our <u>website</u> or see below for sign up.	
VirtualOutcomes	Community Pharmacy Devon funds this online training platform to support our pharmacy teams in Devon. Therefore, it is free for all pharmacy teams in Devon. A new module is released every month. The latest module has just been released to support engagement with the ABPM part of the Hypertension Case Finding Service and maximising the service. Find it here.
