Pharmacy First Caps September 2025	Updated Pharmacy First caps come into force for September 2025. If you haven't already done so, check the NHSBSA website to see what your Pharmacy First cap is for this month	
Pharmacy Profile Update 30th September 2025	Ensure your Directory of Services and NHS website profiles are up to date by updating your NHS Profile Manager. This quarter starts on 1st July 2025 and ends on 30th Sept 2025. We would encourage you to do this asap.	
PQS: The antimicrobial Stewardship 1st Sept 2025 – 31st Mar 2025	The Pharmacy First consultations clinical audit can be started from the 1st September 2025. The 2025-26 clinical audit should be conducted from 1st September 2025 and completed no later than 31st March 2026

PharmOutcomes Access	Check that pharmacy staff have access to PharmOutcomes during all opening times, especially when locums are on duty ; set-up additional accounts if needed. PharmOutcomes must be checked regularly throughout the day and referrals and messages received actioned.	
Community Pharmacy Devon Mailing List	Encourage locums and the rest of your pharmacy team to join our mailing list to ensure they are up to date with changes. Visit our website or see below for sign up. Sometimes (why?) emails from CP Devon go into the NHS Spam Filers. Please check for this otherwise you might miss out on important information!
